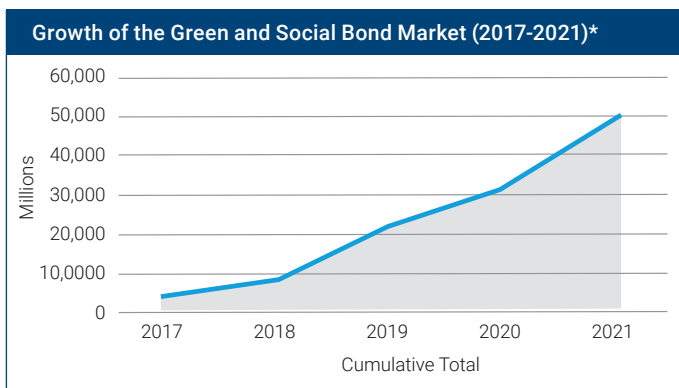

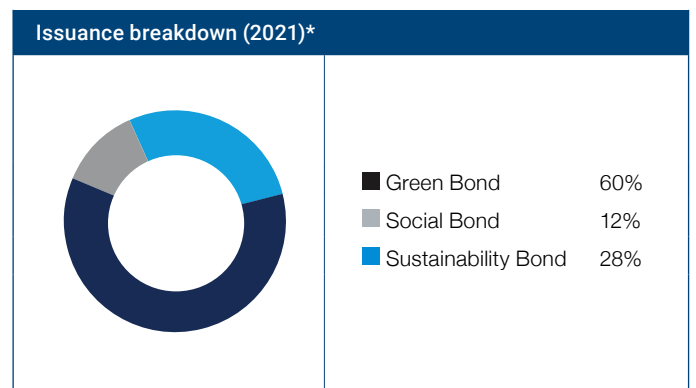

Investment approach for the Green Bond Fund

- ▲ The Fund will invest in a range of green, sustainable/sustainability-linked, and social bonds from providers that conduct their business and apply capital responsibly, giving consideration to a range of Environmental Social & Governance (ESG) issues
- ▲ The Fund will invest in a broad range of fixed interest securities along with cash and similar investments/funds. These may include direct or indirect international and domestic holdings of government, corporate and asset backed securities issued in Australian dollars or appropriately hedged
- ▲ The investment manager may also use derivatives for portfolio positioning and managing market risk
- ▲ The Fund has the ability to borrow funds for day-to-day operational activities but will not use gearing in implementing portfolio positions
