## Update on merger with Altius Sustainable Bond Fund

Further to our previous announcement on 29 November 2021, Australian Unity Funds Management Limited as responsible entity of the Altius Bond Fund (Fund), is pleased to announce that the merger of the Fund with Altius Sustainable Bond Fund (ASBF) by way of scrip for scrip merger (Merger) has been completed.

The Merger was implemented with an effective date of 7 December 2021, whereby ASBF acquired all units on issue in the Fund at a value equal to the net asset value per unit of the Fund, in exchange for issuing ASBF units to Fund investors at a value equal to the net asset value per unit of ASBF.

The means that investors that held units in the Fund now hold units in ASBF.

The Fund and ASBF offer similar investment strategies, objectives and permitted investments, and are managed by the same team at Altius Asset Management. Fund investors, who now own units in ASBF, benefit from ASBF's lower management fee and more contemporary sustainability overlay.

Investors in the Fund will receive individual statements confirming:

- (i) the redemption of their entire holding from the Fund; and
- (ii) an application into ASBF for a value equivalent to the value of their holding in the Fund immediately prior to the Merger.
