# Target Market Determination Altius Sustainable Short Term Income Fund



## Introduction

This Target Market Determination (**TMD**) is required under section 994B of the *Corporations Act 2001* (Cth) (**the Act**). This TMD describes the class of consumers that comprises the target market for the financial product and matters relevant to the product's distribution and review (specifically, distribution conditions, review triggers and periods, and reporting requirements). Distributors must take reasonable steps that will, or are reasonably likely to, result in distribution of the product being consistent with the most recent TMD (unless the distribution is excluded conduct).

## Target Market Summary

This product is intended for use as up to a minor component within a portfolio for a consumer who is seeking capital preservation or income distribution and has a medium risk and return profile for that portion of their investment portfolio. It is likely to be consistent with the financial situation and needs of a consumer with an investment timeframe of 3 years or more and needs access to their capital within one week of the request.

## **Description of Target Market**

#### Appropriateness

#### Investment products and diversification
